



Recycling Rewards July - August 2026

Detailed Rules

NO PURCHASE OR PAYMENT OF ANY KIND NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT ENHANCE YOUR ABILITY TO PARTICIPATE OR WIN. THIS CONTEST IS INTENDED FOR ENTRY IN CANADA AND WILL BE GOVERNED BY CANADIAN LAW. DO NOT ENTER IF YOU ARE NOT ELIGIBLE AND LOCATED IN CANADA AT THE TIME OF ENTRY.

1. ELIGIBILITY: OPEN ONLY TO LEGAL RESIDENTS OF ALL PROVINCES OF CANADA WITH THE EXCEPTION OF QUEBEC WHO HAVE ATTAINED THE AGE OF MAJORITY IN THEIR PROVINCE OR TERRITORY OF RESIDENCE AS OF DATE OF ENTRY. Employees, officers and directors of TerraCycle Canada ULC. ("Sponsor"), their respective parents, subsidiaries, and affiliated companies, promotional partners and advertising and Contest agencies, representatives, agents, web masters/suppliers (and their dependents, immediate family members [spouse, parents, children, siblings] and persons with whom they are domiciled, whether or not related) are not eligible to participate. Specific Eligibility: The Promotion is open to participating locations in the recycling programs as announced on promotion webpage, <https://www.terracycle.com/en-CA/contests/terracycle-recycling-rewards> ("Participating Recycling Program"). All TerraCycle collections locations are automatically enrolled if they are confirmed and active (not on a waitlist) in at least one Participating Recycling Program according to their profile on <https://www.terracycle.com/en-CA/> during the Promotional Period outlined below ("Eligible Recycling Location"). The goal of the Promotion is for Eligible Recycling Locations to earn bonus points for recycling through the Participating Program, however TerraCycle reserves the right to limit the total allowable Outstanding Labels (Outstanding Labels) per TerraCycle account to a reasonable level to control abuses. For more information on the limit of Outstanding Labels for each Participating Program please contact customercare@terracycle.ca. You may sign up and participate in the Participating Recycling Program at no charge at https://www.terracycle.com/en-CA/account/sign_up. The list of Participating Recycling Programs will be updated every two (2) months.



2. **PROMOTIONAL PERIOD:** The Promotion will begin on July 1st, 2026 at 12:00am EST and end on August 31st, 2026 at 11:59 pm EST (“Promotional Period”). Collection packages delivered and checked in at TerraCycle’s facilities as shown on your TerraCycle account between those times will be eligible for the Promotion.

3. **HOW TO ENTER:** Eligible Recycling Locations meeting the above described conditions (1a) are automatically enrolled in the Promotion. To compete in the incentive program the Eligible Recycling Location must ship accepted packaging waste to TerraCycle through the Participating Recycling Program during the Promotion Period.

4. **PRIZE:** Each shipment received from an Eligible Recycling Location in the Participating Recycling Program and checked into TerraCycle facilities as reflected in an Eligible Recycling Location’s TerraCycle account during the Promotional Period will be credited with two hundred (200) bonus points plus one (1) entry into a monthly sweepstakes. TerraCycle will randomly select one (1) winner from the pool of shipments to receive a free small All-In-One Zero Waste Box (ARV \$289.00). Odds will depend on number of eligible entries received for the drawing. Each TerraCycle point can be redeemed for payment of \$0.01 per point to the non-profit organization of your choice. Bonus points will be credited to the Eligible Recycling Location’s TerraCycle account no later than the end of the following month.

Sponsor reserves the right, in its sole discretion, to cancel, terminate, modify, extend or suspend this Promotion should (in its sole discretion) virus, bugs, non-authorized human intervention, fraud, epidemics or other causes beyond its control corrupt or affect the administration, security, fairness or proper conduct of the Promotion. In such case, Sponsor will select the winners from all eligible entries received prior to and/or after (if appropriate) the action taken by Sponsor.
