The Febreze Spring Cleaning Challenge Air and Home Care Recycling Programme

- 4. To enter the promotion, participants must collect used air fresheners and home care waste and send them to TerraCycle using the freepost address label they can find by logging onto their TerraCycle account at www.terracycle.co.uk
- 5. Winners will be determined by absolute collection numbers within the contest timelines outlined in point 3 above.
- 6. Fifty winners will receive charity points and in total 136,500 TerraCycle points will be given away as part of the competition (worth £1,365).
