## Recycle for our Planet

## **Contest Terms and Conditions**

- The Recycle for our Planet contest is open to individuals aged eighteen (18) or over in the United Kingdom and the Isle of Wight (not available for the Isle of Man and the Channel Islands), however, the Promoter's employees, their families, their agents or anyone else connected to the contest are excluded from participating.
- 2. The promotion period will start on Wednesday 20th April 2022 at 9:00am and ends on Tuesday 31st May 2022 at 5.00pm.

Prior to entering the contest, participants must have a TerraCycle account (created via the TerraCycle website <a href="https://www.terracycle.com/en-GB/account/sign\_up">https://www.terracycle.com/en-GB/account/sign\_up</a>) and have successfully joined at least one of the participating programmes listed in point 3. To sign up to a programme, the participant must click on the hyperlinked programme above and read, then complete, the steps listed in the 'How it Works' section.
- 5. To enter, participants must ensure they are a member (by setting up a public drop-off location or becoming a private collector) of at least one of the nine participating recycling programmes as listed in point 3 and have successfully filled out the <a href="mailto:sign-up form">sign-up form</a> available on the contest page: <a href="https://www.terracycle.com/en-GB/contests/race-to-recycle-uk">https://www.terracycle.com/en-GB/contests/race-to-recycle-uk</a>. Participants then need to collect the corresponding accepted waste for the recycling programmes they are participating in. Once enough waste to meet the minimum weight

requirement has been collected, participants need to send the waste to TerraCycle® using a free shipping label accessible by logging into their TerraCycle® account, which can be found here: https://www.terracycle.com/en-GB/account/sign\_in.

- 6. Parcels weighing the relevant recycling programme's minimum weight (visible on the corresponding programme page on the TerraCycle website) and containing waste accepted in the corresponding participating recycling programmes, sent by Tuesday 31st May 2022 and received at our Material Recovery Facility (MRF) between Wednesday 20th April 2022 at 9:00am and Tuesday 14th June 2022 at 5.00pm will be accepted and counted as an entry. Please note if a parcel is checked in before the Promoter receives online confirmation that the participant has filled in the participation form, the parcel will not be eligible for the bonus points or sweepstake prize.
- 7. The types of accepted waste are outlined on the individual programme pages (linked in point 3). Please note that waste from different recycling programmes can not be sent in the same parcel because the different waste types need to be kept separately for recycling purposes.
- 8. Only the first 250 parcels (across all participating programmes) that contain accepted waste and meet the minimum parcel weight of the related recycling programme, will win 500 bonus TerraCycle points (1 point = £0.01). Sending multiple parcels across multiple participating programmes is allowed and points will be awarded on a first-come, first-served basis to the first 250 parcels.
- 9. We advise participants to send their last parcels no later than 31st May 2022, so they arrive on time and can be counted in the contest. To win the 500 bonus TerraCycle points, we advise participants to send their parcel(s) as soon as possible as these are awarded on a first-come, first-served basis to the first 250 parcels received. Participants can send multiple parcels.
