## Rewind, Recharge, RECYCLE Contest terms and conditions

- The Rewind, Recharge, RECYCLE contest is open to all individuals aged eighteen (18) or over residing in the United Kingdom (it is not available for residents of the Isle of Man and the Channel Islands). That being said, the Promoter's employees, their families, their agents or anyone else connected to the contest are excluded from participating.
- 2. The contest will run from Monday 29th August 2022 at 9:00 am until Friday 7th October 2022 at 5:00 pm.
- 3. The participating recycling programmes are as follows:
  - The Babybel® Free Recycling Programme
  - The Cheese Packaging Free Recycling Programme
  - The Pringles® Tube Free Recycling Programme
  - The pladis Biscuits and Snacks Free Recycling Programme
  - The Colgate® and hello® Oral Care Free Recycling Programme
- 4. Prior to entering the contest, participants must have a TerraCycle account (created <a href="here">here</a>) and have successfully joined the relevant participating programmes that they would like to enter the contest under (as listed in point 3). Participants will need to be have joined at least one of the participating programmes. To sign up to a programme, participants must click on the hyperlinked programme above and read, then complete, the steps listed in the 'How it Works' section.
- 5. To enter, participants must ensure they are a member (by setting up a public drop-off location or becoming a private collector) of each of the participating recycling programmes that they'd like to collect for (as listed in point 3), and have successfully filled out the <a href="sign-up form">sign-up form</a> available on <a href="the contest page">the contest page</a>. Participants then need to collect the corresponding accepted waste for the recycling programmes they have chosen to participating in. Once the participants have collected enough rubbish to meet the minimum weight requirements, they must send their parcels of rubbish to TerraCycle using a prepaid shipping label accessible via their <a href="TerraCycle account">TerraCycle account</a>.
- 6. Parcels weighing the relevant recycling programme's minimum weight (visible on the corresponding programme page on the TerraCycle website) and containing waste accepted in the corresponding participating recycling programmes, sent by Friday 7th October 2022 and received at our Material Recovery Facility (MRF) between Monday 29th August 2022 at 9:00 am and Thursday 13th October 2022 at 5:00 pm will be accepted and counted as an entry. Please note if a parcel is checked in before the Promoter receives online confirmation that the participant has filled in the participation form, the parcel will not be eligible for the bonus points.

- 7. The types of accepted waste are outlined on each programme page (linked in point 3). Please note that products or packaging from different recycling programmes cannot be sent in the same parcel for recycling purposes, the various products and packaging must be kept separate.
- 8. Only the first 250 parcels (across all participating programmes) that contain accepted waste and meet the minimum weight requirement of the related recycling programme, will win 1,000 bonus TerraCycle points (1,000 points = £10). Sending multiple parcels across multiple participating programmes is allowed and points will be awarded on a first-come, first-served basis to the first 250 parcels.
- 9. We advise participants to send their parcel(s) as soon as possible, and no later than 7th October 2022, as the 1,000 bonus TerraCycle points are awarded on a first-come, first-served basis for the first 250 parcels received.
- 10. Please note that TerraCycle is not responsible for any parcels lost or delayed in transit. Proof of posting is not proof of receipt.
- 11. No alternative prizes in whole, or in part, will be given to the winners to replace the bonus TerraCycle points.
