## **Do Good Campaign Terms and Conditions**

- 2. The promotion will run from Tuesday 15th November 2022 at 9:00 am until Monday 16th January 2023 at 5:00 pm. Please note that TerraCycle is not responsible for any parcels lost or delayed in transit. Proof of postage is not proof of receipt.
- 3. Prior to sending parcels, collectors must have successfully opened a TerraCycle account (created <a href="here">here</a>) and joined the participating programme(s) they're collecting rubbish for.
- 4. Participants will earn bonus TerraCycle points for their first 8 weight-compliant parcels sent between 15th November 2022 and 16th January 2023 for any number of the following participating programmes:
