## **End-of-Year Contest Terms and Conditions**

- 4) Prior to entering the contest, participants must have a TerraCycle account (created via the TerraCycle website <a href="https://www.terracycle.com/en-GB/account/sign\_up">https://www.terracycle.com/en-GB/account/sign\_up</a>) and have successfully joined at least one of the participating programmes listed in point 3. To sign up to a programme, the participant must click on the relevant hyperlinked programme above and read, then complete, the steps listed in the 'How it Works' section.
- 5) To enter, participants must ensure they are a member (by setting up a public drop-off point or becoming a private collector) of at least one of the participating recycling programmes as listed in point 3. Participants then need to collect the corresponding accepted waste for the recycling programmes they are participating in. Once enough waste has been collected to meet the minimum weight requirement, participants need to send the waste to TerraCycle® using a free shipping label accessible by logging into their TerraCycle® account, which can be found here: <a href="https://www.terracycle.com/en-GB/account/collection-programs">https://www.terracycle.com/en-GB/account/collection-programs</a>.
- 6) Parcels weighing the relevant minimum weight required by each participating recycling programme (visible on the corresponding programme page on the TerraCycle website) and containing waste accepted by the participating recycling programmes, sent by 29th December 2025 will be accepted and counted as an entry.
- 7) The types of accepted waste are outlined on the individual programme pages (linked in point 3). Please note that waste from different recycling programmes can not be sent in

- the same parcel because the different waste types need to be kept separately for recycling purposes.
- 8) Participants can get a bonus of 500 TerraCycle points (£5) when they send a shipment to us for one or more of the participating programmes.
- 9) Only the first 400 parcels (across all participating programmes) that contain accepted waste and meet the minimum parcel weight requirement of the relevant recycling programme, will win the 500 bonus TerraCycle points (1 point = £0.01). Sending multiple parcels across multiple participating programmes is allowed and points will be awarded on a first-come, first-served basis to the first 400 parcels.
- 10) Please note that TerraCycle is not responsible for any parcels that are lost or delayed in transit. Proof of posting is not proof of receipt.
- 11) No alternative prizes in whole or in part will be given to the winners to replace the bonus TerraCycle points.
- 12) The bonus points will be awarded 10 weeks after the contest has ended. Please also note that, in order for your points to be credited, you must still be signed up, at the end of the contest, to the participating programme(s) you joined during this period.
