

TerraCycle's First Shipment Contest Terms and Conditions

1. The First Shipment Contest is open to individuals aged eighteen (18) or over in the United Kingdom and the Isle of Wight (not available for the Isle of Man and the Channel Islands); however, the Promoter's employees, their families, their agents or anyone else connected to the contest are excluded from participating.
2. This Contest is open only to individuals who have not sent a shipment to TerraCycle in the last 12 months prior to 02.03.2026, or who have never previously sent a shipment.
3. The contest period will start on **02.03.2026 at 9:00 am** and end on **30.04.2026 at 11:59 pm**
4. The participating recycling programmes are as follows:

Prior to entering the contest, participants must either: Create a TerraCycle account via the TerraCycle website (https://www.terracycle.com/en-GB/account/sign_up), or log in to their existing TerraCycle account, and have successfully joined at least one of the participating programmes listed above.
6. To enter, participants must ensure they are a member (by setting up a public drop-off point) of at least one of the participating recycling programmes listed above. For more information check the section "How to become a public drop-off point" on each programme page
7. Participants must then collect the corresponding accepted waste for the recycling programme(s) they are participating in. Once enough accepted waste has been collected to meet the minimum weight requirement, participants must send the waste to TerraCycle® using a free shipping label accessible by logging into their TerraCycle® account, which can be found here:

8. Parcels weighing the relevant minimum weight required by each participating recycling programme (visible on the corresponding programme page on the TerraCycle website) and containing waste accepted by the participating recycling programmes, and dispatched no later than 30.04.2026 at 11:59 pm, will be accepted and counted as an

entry.

9. The types of accepted waste are outlined on the individual programme pages (linked above). Please note that waste from different recycling programmes cannot be sent in the same parcel because the different waste types need to be kept separately for recycling purposes.
10. Participants can receive a bonus of **1000 TerraCycle points (£10)** when they send a compliant shipment to us for one or more of the participating programmes during the contest period.
11. Each compliant shipment received during the contest period will be eligible to receive the 1000 TerraCycle bonus points, provided it is among the first 50 qualifying parcels received across all participating programmes. There is no limit to the number of bonus awards a participant may receive, provided that each qualifying shipment is among the first 50 qualifying parcels received across all participating programmes during the contest period.
12. Only the first **50 parcels** (across all participating programmes) that contain accepted waste and meet the minimum parcel weight requirement of the relevant recycling programme will receive the **1000 bonus TerraCycle points (1 point = £0.01)**. Sending multiple parcels across multiple participating programmes is allowed, and bonus points will be awarded on a first-come, first-served basis to the first **50 qualifying parcels**.
13. Please note that TerraCycle is not responsible for any parcels that are lost or delayed in transit. Proof of posting is not proof of receipt.
14. No alternative prizes in whole or in part will be given to replace the bonus TerraCycle points.
15. The bonus points will be awarded 10 weeks after the contest has ended. Please also note that, in order for your points to be credited, you must still be signed up, at the end of the contest, to the participating programme(s) you joined during this period.
16. Winners may be required to participate in some reasonable publicity at no expense to the Promoter.
