

TerraCycle's Snack packaging prize draw

Terms and conditions

1. The Snack packaging prize draw is open to individuals aged eighteen (18) or over in the United Kingdom and the Isle of Wight. It is not available for the Isle of Man or the Channel Islands. The Promoter's employees, their families, their agents, or anyone else connected to the contest are excluded from participating.
2. The contest period will start on 10.08.2026 at 9:00 am and end on 06.09.2026 at 11:59 pm.
3. The participating recycling programmes are as follows:

4. Prior to entering the contest, participants must either create a TerraCycle account via the TerraCycle website or log in to their existing TerraCycle account.
5. To enter, participants must be signed up to at least one of the participating programmes listed above.
6. To sign up to a programme, the participant must click on the relevant programme and read, then complete, the steps listed in the "How it works" section on the programme page.
7. Participants must collect the corresponding accepted snack packaging for the recycling programme they are participating in. Once enough accepted packaging has been collected to meet the minimum weight requirement, participants must send the packaging to TerraCycle® using a free shipping label accessible by logging into their TerraCycle account.
8. Shipments containing accepted snack packaging from one of the participating programmes, meeting the minimum shipment weight requirement listed on the relevant programme page, and sent during the contest period will be accepted and counted as entries.
9. The types of accepted snack packaging are outlined on the individual programme pages. Please note that packaging from different recycling programmes cannot be sent in the same parcel because the different item types need to be kept separately for recycling purposes.
10. Each compliant shipment sent during the contest period will count as one entry. Participants may send more than one compliant shipment, but each participant can only win one prize.
11. Ten winners will be selected at random from all eligible entries received during the contest period.
12. The ten winners will receive one of the following prize:
 - 1 x 1,000 TerraCycle points, worth £10
 - 2 x 800 TerraCycle points, worth £8 each
 - 3 x 500 TerraCycle points, worth £5 each
 - 1 x Recycled Soap Holder - TerraCycle®, worth £20
 - 1 x Recycled Coasters - TerraCycle®, worth £26
 - 1 x Set of 2: Medium Round Plant Pot, worth £46

- 1 x Stackable Organisation Set, worth £51
13. Prizes will be allocated at random to the ten winners.
 14. Please note that TerraCycle is not responsible for any parcels that are lost or delayed in transit. Proof of posting is not proof of receipt.
