



# Century™ Join & Win 2021

## Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT ENHANCE YOUR ABILITY TO PARTICIPATE OR WIN. SWEEPSTAKES MAY ONLY BE ENTERED IN OR FROM THE 48 CONTIGUOUS STATES AND D.C. THIS SWEEPSTAKES IS GOVERNED EXCLUSIVELY BY THE LAW OF THE UNITED STATES.

1. **ELIGIBILITY:** The Century™ Join & Win 2021 ("Sweepstakes") is ONLY open to those individuals who are 18 (eighteen) years of age or older as of the date of entry and who are legal residents of the 48 contiguous United States or District of Columbia ("Eligible Region").

3. **WINNERS ANNOUNCED:** Winners will be announced by December 31st, 2021 via email.



**4. HOW TO ENTER:** The goal of the Sweepstakes is for users to sign up for the Century™ Baby Gear Recycling Program (“Participating Recycling Program”) during the Sweepstakes Timeline. Email addresses entered are subject to end-user validation. All participants must have a valid email address. No automated entry devices, bots and/or programs permitted. Entries do not carry over from one week to the next.

**5. DETERMINING WINNERS:** Each participant who joins the Participating Recycling Program will earn one hundred (100) TerraCycle points plus one (1) entry into a weekly sweepstakes. Each participant who visits Century™ on Instagram and Facebook, signs up for the Century™ newsletter, and shares a referral code will earn extra entries. TerraCycle will randomly select 1 winner per week from the pool of signups. Odds will depend on number of eligible entries received for the drawing.
