



# Holiday Collection Contest: VTech® and LeapFrog® Toys

## Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT ENHANCE YOUR ABILITY TO PARTICIPATE OR WIN. THIS CONTEST MAY ONLY BE ENTERED IN OR FROM THE 48 CONTIGUOUS UNITED STATES AND D.C. ONLY. THIS CONTEST IS GOVERNED EXCLUSIVELY BY U.S. LAW.

1. **ELIGIBILITY:** The VTech® and LeapFrog® Toys Holiday Collection Contest (“Contest”) is ONLY open to those individuals (“Participants”) who are 18 (eighteen) years of age or older as of the date of entry and who are legal residents of the 48 contiguous United States or District of Columbia (“Eligible Region”).

Employees, officers and directors of TerraCycle, Inc. (“Sponsor”), VTech® and LeapFrog® (“Promotion Partner”), and their respective parent companies, subsidiaries, affiliates, partners, advertising and promotion agencies, manufacturers or distributors of Contest materials and their immediate families (parents, children, siblings, spouse) or members of the same household (whether related or not) of such employees/officers/directors are not eligible to participate. 1a. **Specific Eligibility:** VTech® and LeapFrog® Toys Holiday Collection Contest (“Contest”) is open to members of the VTech® and LeapFrog® Toys Recycling Program (“Participating Recycling Program”). All members are automatically enrolled if they are a confirmed and active in the Participating Recycling Program according to their profile on [www.terracycle.com](https://www.terracycle.com/en-US/brigades/vtech-leapfrog). 2. **PROMOTIONAL PERIOD:** The Contest will run from December 1, 2021 at 6:00am EST to January 31, 2022 11:59pm EST (“Contest Timeline”).

3. **WINNER’S ANNOUNCED:** Winners will be announced by February 28, 2022 via email.

4. **HOW TO ENTER:** Participants meeting the conditions set forth in paragraph number 1 above are automatically enrolled in the Contest. The goal of the Contest is for the Participants



within the Participating Program to collect and recycle the accepted waste for the Participating Program. Shipments of all sizes and weights are eligible for this promotion.

**5. DETERMINING WINNERS:** Each participant who sends in a qualifying shipment during the promotion period will earn one hundred (100) TerraCycle points. In addition, the top three (3) shippers will receive another one hundred (100) TerraCycle points and a prize pack from VTech® and LeapFrog®. Total ARV of prizes is \$50.00. Each TerraCycle point can be redeemed for payment of \$0.01 per point to the non-profit organization of your choice. Winners have fourteen (14) days to respond to notification of reward with non-PO Box shipping address. If winner does not respond to Sponsor communication within the time allotted, the prize may be forfeited in its entirety. Sponsor reserves the right, in its sole discretion, to cancel, terminate, modify, extend or suspend this Contest should (in its sole discretion) virus, bugs, non-authorized human intervention, fraud, epidemics or other causes beyond its control corrupt or affect the administration, security, fairness or proper conduct of the Contest. In such case, Sponsor will select the winners from all eligible entries received prior to and/or after (if appropriate) the action taken by Sponsor.

Any such controversy or claim shall be arbitrated on an individual basis, and shall not be consolidated in any arbitration with any claim or controversy of any other party. The arbitration shall be conducted in the State of New Jersey, City of Trenton. THESE OFFICIAL RULES AND THE INTERPRETATION OF ITS TERMS SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW JERSEY WITHOUT REGARD TO ITS CONFLICTS OF LAWS RULES. For any matters which are not subject to arbitration as set forth in these Official Rules and/or in connection with the entering of any judgment on an arbitration award in connection with these Official Rules and/or the Contest, the parties irrevocably submit and consent to the exclusive jurisdiction and venue of the state and federal courts located in or closest to the city of Trenton in the State of New Jersey. The parties agree not to raise the defense of forum non conveniens.
