Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT ENHANCE YOUR ABILITY TO PARTICIPATE OR WIN. THIS CONTEST IS INTENDED FOR ENTRY IN CANADA AND WILL BE GOVERNED BY CANADIAN LAW. DO NOT ENTER IF YOU ARE NOT ELIGIBLE AND LOCATED IN CANADA AT THE TIME OF ENTRY.

- 1. ELIGIBILITY: OPEN ONLY TO LEGAL RESIDENTS OF ALL PROVINCES AND TERRITORIES OF CANADA WITH THE EXCEPTION OF QUEBEC WHO HAVE ATTAINED THE AGE OF MAJORITY IN THEIR PROVINCE OR TERRITORY OF RESIDENCE AS OF DATE OF ENTRY.
