



Sustainable Sign-Up December 2025

Official Rules

THIS PROMOTION MAY ONLY BE ENTERED IN OR FROM THE 48 CONTIGUOUS STATES AND D.C. ONLY AND WILL BE GOVERNED BY U.S. LAW. DO NOT ENTER IF YOU ARE NOT ELIGIBLE AND LOCATED OUTSIDE OF THE 48 CONTIGUOUS STATES AND DC AT THE TIME OF ENTRY.

1. **ELIGIBILITY:** Sustainable Sign-Up December 2025 ("Promotion") is ONLY open to those individuals ("Participants") who are 18 (eighteen) years of age or older as of the date of entry and who are legal residents of the 48 contiguous United States or District of Columbia ("Eligible Region").

2. **PROMOTIONAL PERIOD:** The Promotion begins at 12:00 a.m. Eastern Time on December 1st, 2025 and ends at 11:59:59 p.m. Eastern Time on December 31st, 2025 ("Promotion Timeline").

3. **HOW TO ENTER:** The goal of the Promotion is for users to sign up for the Participating Recycling Program ("Participating Recycling Program") during the Promotion Timeline. Limit one sign-up per Participating Recycling Program per person. Email addresses entered are subject to end-user validation. All participants must have a valid email address. No automated entry devices, bots and/or programs permitted. Entries do not carry over from one week to the next.

4. **PRIZES:** Each participant who joins the Participating Recycling Program(s) will earn one hundred (100) TerraCycle points plus one (1) entry into a monthly sweepstakes. TerraCycle will randomly select one (1) winner from the pool of signups to receive a free small All-In-One Zero Waste Box (ARV \$241.00).
