



Accepted Waste Guidelines

In this guide, you'll find detailed information about what is accepted and what's not accepted in each TerraCycle Zero Waste Box

The following guidelines are included for each Zero Waste Box:

- **Zero Waste Box product name:** Name of product, listed alphabetically. Note that the name of the box may vary slightly depending on region.
- **Waste stream practical description:** Outlines the types of material and products accepted for the Zero Waste Box.
- **Waste stream technical description:** Provides a more detailed summary of material composition and specific polymers recycled for the associated Zero Waste Box.
- **Restrictions:** Outlines specific materials not accepted in the Zero Waste Box.

Zero Waste Pouches and Pallets

Zero Waste Pouches and Pallets follow the same guidelines as the Zero Waste Box with an identical waste stream name. (E.g., Beauty Products and Packaging - Zero Waste Box™, Beauty Products and Packaging - Zero Waste Pouch, and Beauty Products and Packaging - Zero Waste Pallet.)

Regarding hazardous material

It is the responsibility of the customer to ensure that the waste sent to TerraCycle complies with the accepted guidelines and applicable local regulation. TerraCycle Zero Waste Boxes do not accept regulated or hazardous waste for recycling, unless otherwise specified.
