



Sustainable Sign-Up March 2026

Official Rules

THIS PROMOTION MAY ONLY BE ENTERED IN OR FROM THE 48 CONTIGUOUS STATES AND D.C. ONLY AND WILL BE GOVERNED BY U.S. LAW. DO NOT ENTER IF YOU ARE NOT ELIGIBLE AND LOCATED OUTSIDE OF THE 48 CONTIGUOUS STATES AND DC AT THE TIME OF ENTRY.

1. **ELIGIBILITY:** Sustainable Sign-Up March 2026 (“Promotion”) is ONLY open to those individuals (“Participants”) who are 18 (eighteen) years of age or older as of the date of entry and who are legal residents of the 48 contiguous United States or District of Columbia (“Eligible Region”).

Employees, officers and directors of TerraCycle, US LLC (“Sponsor”), and their respective parent companies, subsidiaries, affiliates, partners, advertising and promotion agencies, manufacturers or distributors of Promotion materials, and their immediate families (parents, children, siblings, spouse) or members of the same household (whether related or not) of such employees/officers/directors are not eligible to participate. 2. **PROMOTIONAL PERIOD:** The Promotion begins at 12:00 a.m. Eastern Time on March 1st, 2026 and ends at 11:59:59 p.m. Eastern Time on March 31st, 2026 (“Promotion Timeline”).

3. **HOW TO ENTER:** The goal of the Promotion is for users to sign up for the Participating Recycling Program (“Participating Recycling Program”) during the Promotion Timeline. The list of Participating Recycling Programs is available on <https://www.terracycle.com/en-US/contests/sustainable-sign-up>. The list will be updated each month with new Participating Recycling Programs. You may sign up for the Participating



Recycling Program at no charge at <https://www.terracycle.com/en-US/contests/sustainable-sign-up>. Limit one sign-up per Participating Recycling Program per person. Email addresses entered are subject to end-user validation. All participants must have a valid email address. No automated entry devices, bots and/or programs permitted. Entries do not carry over from one week to the next.

4. **PRIZES:** Each participant who joins the Participating Recycling Program(s) will earn one hundred (100) TerraCycle points plus one (1) entry into a monthly sweepstakes. TerraCycle will randomly select one (1) winner from the pool of signups to receive a free small All-In-One Zero Waste Box (ARV \$241.00). Odds will depend on number of eligible entries received for the drawing. Each TerraCycle point can be redeemed for payment of \$0.01 per point to the non-profit organization of your choice. Sponsor reserves the right, in its sole discretion, to cancel, terminate, modify, extend or suspend this Promotion should (in its sole discretion) virus, bugs, non-authorized human intervention, fraud, epidemics or other causes beyond its control corrupt or affect the administration, security, fairness or proper conduct of the Promotion. The arbitration shall be conducted in the State of New Jersey, City of Trenton.

For any matters which are not subject to arbitration as set forth in these Official Rules and/or in connection with the entering of any judgment on an arbitration award in connection with these Official Rules and/or the Promotion, the parties irrevocably submit and consent to the exclusive jurisdiction and venue of the state and federal courts located in or closest to the city of Trenton in the State of New Jersey. The parties agree not to raise the defense of forum non conveniens.
