Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT ENHANCE YOUR ABILITY TO PARTICIPATE OR WIN. THIS CONTEST MAY ONLY BE ENTERED IN OR FROM THE 48 CONTIGUOUS UNITED STATES AND D.C. ONLY. THIS CONTEST IS GOVERNED EXCLUSIVELY BY U.S. LAW.

1. **ELIGIBILITY:** OPEN ONLY TO LEGAL RESIDENTS OF THE 48 CONTIGUOUS UNITED STATES OR DISTRICT OF COLUMBIA ("D.C."), 18 YEARS OF AGE OR OLDER AS OF DATE OF ENTRY. 1a. **Specific Eligibility:** innisfree Recycling Contest 2026 ("Sweepstakes") is open to members of the innisfree Free Recycling Program ("Participating Recycling Programs"). All members are automatically enrolled if they are confirmed and active in the Participating Recycling Program according to their profile on www.terracycle.com. 2. **PROMOTIONAL PERIOD:** The sweepstakes will run from April 1, 2026 at 6:00 am PT to July 1, 2026, at 11:59 pm PT ("Sweepstakes Promotion Period").

3. **SWEEPSTAKES ENTRY GUIDELINES:** Eligible Recycling Collectors meeting the above described conditions (1a) are automatically enrolled in the Sweepstakes. To compete in the incentive program the Eligible Recycling Location must ship accepted packaging waste to TerraCycle through a label requested from the Participating Recycling Programs or requested from us.innisfree.com/pages/terracycle-x-innisfree ("Widget") during the Promotion Period. All members are automatically enrolled if they are confirmed and active in the Participating Recycling Program according to their profile on www.terracycle.com. For one (1) qualifying shipment received through one (1) of the Participating Recycling Programs, the participant will receive one (1) entry ("Entry") into the Sweepstakes.



4. **PRIZE:** During the Winner Selection Period, TerraCycle will award double (\$2 per pound) TerraCycle Recycling Rewards points for all qualifying shipments made during the Sweepstakes Promotion Period. TerraCycle will randomly select five (5) winners to each receive one (1) innisfree bundles (ARV \$92) from the pool of received shipments during the Sweepstakes Promotion Period.

Winners have fourteen (14) days to respond to notification of Prize with non-PO Box shipping address and phone number. If a winner does not respond to Sponsor communication within the time allotted, the Prize may be forfeited in its entirety. If a winner cannot accept the prize as stated, the Prize may be forfeited in its entirety.
