



Sustainable Sign-Up April 2026

Official Rules

THIS PROMOTION MAY ONLY BE ENTERED IN OR FROM THE 48 CONTIGUOUS STATES AND D.C. ONLY AND WILL BE GOVERNED BY U.S. LAW. DO NOT ENTER IF YOU ARE NOT ELIGIBLE AND LOCATED OUTSIDE OF THE 48 CONTIGUOUS STATES AND DC AT THE TIME OF ENTRY.

1. **ELIGIBILITY:** Sustainable Sign-Up April 2026 (“Promotion”) is ONLY open to those individuals (“Participants”) who are 18 (eighteen) years of age or older as of the date of entry and who are legal residents of the 48 contiguous United States or District of Columbia (“Eligible Region”).

Email addresses entered are subject to end-user validation. All participants must have a valid email address. No automated entry devices, bots and/or programs permitted. Entries do not carry over from one week to the next.
