



Taco Bell Loyalty Gift Card 2026

Official Rules

2. **PROMOTIONAL PERIOD:** The sweepstakes will run from April 1, 2026 at 6:00 am PT to April 31st, 2026, at 11:59 pm PT ("Sweepstakes Promotion Period").

3. **SWEEPSTAKES ENTRY GUIDELINES:** Eligible Recycling Collectors meeting the above described conditions (1a) are automatically enrolled in the Sweepstakes. To compete in the incentive program the Eligible Recycling Location must ship accepted packaging waste to TerraCycle through a label requested from the Participating Recycling Programs during the Promotion Period. All members are automatically enrolled if they are confirmed and active in the Participating Recycling Program according to their profile on www.terracycle.com. For one (1) qualifying shipment received through the Participating Recycling Program, the participant will receive one (1) entry ("Entry") into the Sweepstakes.



4. **PRIZE:** During the Winner Selection Period, TerraCycle will randomly select five (5) winners to each receive one (1) Taco Bell gift card (ARV \$30) from the pool of received shipments during the Sweepstakes Promotion Period.

Winners have fourteen (14) days to respond to notification of Prize with non-PO Box shipping address and phone number. If a winner does not respond to Sponsor communication within the time allotted, the Prize may be forfeited in its entirety.
