



# Febreze DRIVE

## Detailed Rules

NO PURCHASE OR PAYMENT OF ANY KIND NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT ENHANCE YOUR ABILITY TO PARTICIPATE OR WIN.

THIS CONTEST IS INTENDED FOR ENTRY IN THE 50 UNITED STATES AND D.C. ONLY AND WILL BE GOVERNED BY U.S. LAW. DO NOT ENTER IF YOU ARE NOT ELIGIBLE AND LOCATED IN THE UNITED STATES AT THE TIME OF ENTRY.

1. **ELIGIBILITY:** The “Febreze DRIVE” (“Contest”) is open to everyone Participants in the Febreze Air Care Recycling Program (“Participating Program”) as indicated by their profile on [www.terracycle.com](http://www.terracycle.com). Employees, officers and directors of TerraCycle, Inc. (“Sponsor”), and each of their respective parents, subsidiaries, affiliated companies and members, advertising, promotion, or production agencies, web masters/suppliers (and their IRS dependents, immediate family members [spouse, parents, children, siblings] and individuals residing in their same household, whether or not related) are not eligible to participate. By participating, entrant Schools and other participants agree to these Official Rules, the decisions of the Sponsor and/or its independent judging agency, which are final and binding in all respects. ### a. Specific Eligibility

All TerraCycle participants are automatically enrolled if they are an Active member of the Participating Program according to their profile on [www.terracycle.com](http://www.terracycle.com) (“Sponsor Website”). Participants that have been deleted or are wait-listed to join the Participating Program are not Active members of the program. 2. **CONTEST PERIOD:** Contest will run from March 1<sup>st</sup>, 2018 at 9:00 am Pacific Standard Time (“PST”) to May 31<sup>st</sup>, 2018 at 11:59 pm PST (“Contest Period”).

3. **TO ENTER:** Participants meeting the conditions set forth in paragraph number 1 above are automatically enrolled in the Contest. The goal of the Contest is for the Participants within the Participating Program to collect and recycle the accepted waste for the Participating Program.



Sending in one (1) shipment of accepted waste through the Participating Program during the Contest Timeline constitutes as one (1) entry (Entry) to the Contest.

4. DETERMINATION OF WINNERS: All Participating Recycling Program Participants are eligible for the Contest. Each Entry will be rewarded with one hundred (1) bonus TerraCycle points, and the first Entry will be placed into a sweepstakes. One (1) Entry at random will be selected and awarded a grand Prize. ("Grand Prize").

5. NOTIFICATION: Contest winners will be notified by phone, mail, or email on or around June 15<sup>th</sup>, 2018. Winner is found to be ineligible or not in compliance with these Official Rules, or if any of the prize notifications or prizes are returned as undeliverable, the prize in its entirety may be forfeited.

6. GRAND PRIZE: The Grand Prize winner will a one year supply of Febreze CAR air fresheners, for a total of twelve (12). (Total ARV \$60.00)
